# TENANT OPPORTUNIY TO PURCHASE ACT.

Tenants have lived in horrible conditions, and Landlords and Investors refuse to make repairs. Sometimes tenants are bullied and afraid of evictions and they just move. The landlord will just re-rent it without making any repairs. Sometimes the City of Rochester will fine the Landlord and they pay the fine because it is cheaper than making repairs. So, tenants complain about the condition and get evicted.

In order for the Tenant Opportunity to Purchase Act (TOPA) to work, there needs to be a funding source. Creating a Housing Trust Fund (HTF) would set aside funding as well as create a Tenant Purchase Assistant Program (TPAP). A progressive tax fee would be a way to fund TOPA. We introduced this to Mayor Lovely Warren and created a team which included City-Wide Tenants Union (CWTU) however, none of the recommendations we made were accepted.

The Anti-Displacement Learning Network program through Enterprise was also creating funding for a pilot program. We have been told lie after lie that the Community Land Trust (CLT) could not be used because they were already receiving funding. The CLT is receiving funding from Enterprise for a legal consultant. The program they created had three Request for Proposals (RFP); the CLT was the only program that had everything they were asking for. Pathstone and Homeleasing also applied and had nothing with low income, affordability and permanent ownership. It is sad.

# Walking with Mercy

NETWORK is an organization of women religious who have been advocating and lobbying in Washington D.C. for 50 years. The focus primarily is on Catholic Social Justice Teachings, but it goes beyond that. NETWORK believes in working toward a more just world that allows every person to live with dignity by standing in solidarity with the poor and oppressed.

Some of the issues NETWORK lobbies for are: the Federal budget and where the monies are allocated; food security; affordable health care; a living wage; mass incarceration; police reform; fair trade; immigration reform; racism within the governmental and societal systems; and fair, yet affordable, housing.

If you remember, a number of years ago, NETWORK had the campaign of "Nuns on the Bus." The idea was to have six Sisters ride this bus around the country, stopping in some of the hardest hit cities to listen to the stories of the marginalized and bring attention to those impacted most by the inequity that exists in society.

By invitation, the Bus came to Rochester. The Sisters of Mercy, the Sisters of St. Joseph along with Associates and other supporters made stops, at The House of Mercy, the Homeless encampment, the Catholic Workers House on South Avenue, and the senior care center on Lyell Avenue. At each one of these stops, we heard talks by advocates as well as those who were impacted. Once you listen and hear about these injustices you must act.

Right now, the City of Rochester is in crisis. The violence that has broken out is at an all-time high, and shows no signs of letting up. The evictions and housing crisis we have because of Covid is at crisis levels. We must act now, not later.

One or even two groups cannot change systems. It's going to take everyone working together. By joining and working with the different communities within RocACTS, we know that we can bring about change in order to make Rochester, and beyond, a more equitable place where people can live with dignity and security.
